



Cricket Hall of Fame (First in the World) T 20 World Cup Legends Cricket Tournament

Preamble

Embracing the spirit of the game means participating, either as a player or as an official, fairly and exhibiting respect for other players and officials and the game's traditional values such as graciousness in defeat and humility in victory. The Cricket Hall of Fame, USA T20 Legend World Cup Tournament Code of Behavior is intended to protect and enshrine these important qualities and standards so that all may continue to enjoy the game of cricket now and in the future.

The Spirit of Cricket

Cricket is a game that owes much of its unique appeal to the fact that it should be played not only within its Laws but also within the Spirit of the Game. Any action which is seen to abuse this spirit causes injury to the game itself. The major responsibility for ensuring the spirit of fair play rests with the captains.

1 . There are two Laws which place responsibility for the team's conduct firmly on the captain.

Responsibility of captains

The captains are responsible at all times for ensuring that play is conducted within the Spirit of the Game as well as within the Laws.

Player's conduct

In the event of a player failing to comply with instructions by an umpire, or criticizing by word or action the decision of an umpire, or showing dissent, or generally behaving in a manner which might bring the game into disrepute, the umpire concerned shall in the first place report the

matter to the other umpire and to the player's captain, and instruct the latter to take action.

2. Fair and unfair play

According to the Laws the umpires are the sole judges of fair and unfair play. The umpires may intervene at any time and it is the responsibility of the captain to take action where required.

3. The umpires are authorized to intervene in cases of:

- Time wasting.
- Damaging the pitch.
- Dangerous or unfair bowling.
- Tampering with the ball.
- Any other action that they consider to be unfair.

4. The Spirit of the Game involves RESPECT for:

- Your opponents.
- Your own captain.
- The roles of the umpires.
- The game's traditional values.

5. It is against the Spirit of the Game:

- To dispute an umpire's decision by word, action or gesture.
- To direct abusive language towards an opponent or umpire.
- To indulge in cheating or any sharp practice, for instance:
 - (a) to appeal knowing that the batsman is not out.
 - (b) to advance towards an umpire in an aggressive manner when appealing.
 - (c) to seek to distract an opponent either verbally or by harassment with persistent clapping or unnecessary noise under the guise of enthusiasm and motivation of one's own side.

6. Violence

There is no place for any act of violence on the field of play.

7. Players

- Captains and umpires together set the tone for the conduct of a cricket match.
- Every player is expected to make an important contribution towards this.

CODE OF CONDUCT

Players, captains, managers and officials of all participating teams are expected to maintain the spirit and decorum of the game of Cricket at all times during the tournament. Everyone involved (includes officials) or participating in the Cricket Hall Of Fame T20 World Cup Legends Tournament must agree to the Rules & Regulations outlined.

Any player or team in breach of the rules, spirit of cricket or bringing the Cricket Hall Of Fame T20 World Cup Legends Tournament and its host CCUSA or the game into disrepute will be terminated from further participation in the Tournament. Further, by players nomination, the player shall be deemed to have agreed to abide by all the applicable ICC Regulations pertaining

to International Cricket and in particular, the Clothing and Equipment Regulations, the Code of Conduct for Players and Player Support Personnel (hereafter referred to as the ICC Code of Conduct), the Anti-Racism / discrimination Code for Players and Player Support Personnel, the Anti-Doping Code and the Anti-Corruption Code.

ICC Game Procedure

Playing Conditions for T20 will be adopted with some minor exceptions as described later in this document.

Management

The control of the Competition shall be managed T20 world cup Legends Tournament Committee consists of representatives from CHOF (Cricket Hall Of Fame) & CCUSA (Cricket Council USA)

The Tournament Committee reserves all rights to alter the tournament format and / or structure as deemed necessary by circumstances beyond the control, including but not limited to grounds, weather and light conditions.

The Host

The Inaugural Cricket Hall Of Fame T20 World Cup Legends Tournament will be hosted by Cricket Council USA (CCUSA) at Central Broward Regional Park, 3700 NW 11th P lace, Lauderhill, Florida, 33311. Park Office Contact # + 1 954 357 5400.

Tournament Committee:

A six (6) member Executive Panel will be the oversight committee of the tournament.

Three (3) Members from CHOF and Three (3) Members from CCUSA.

This Executive panel must maintain the highest degree of standards and ethics throughout the tournament. Tournament Committee member cannot represent any team and cannot participate on field team during this tournament.

Cricket Hall Of Fame T20 World Cup Legends Tournament Committee Members are as follows:

Tournament Committee reserves the right to make any changes to the schedule if required. The committee's decision is final and binding on its absolute discretion to impose any penalty by way of warning and/or fine and/or reprimand the participants in respect of the tournament.

Members will share the important roles during the tournament.

The Cricket Hall of Fame T20 World Cup Legends Tournament Committee will be responsible for all matters in addition to communicating with all parties involved (CHOH, CCUSA and Team Owners).

Umpires and Match Referees with the ICC Level experience (minimum 10 games) must be given higher priority in consideration for appointments. The committee and the match referee will appoint the umpires for the finals and other games.

All accreditations (players, staff, vendors, suppliers, sponsors, media, & any other staffing needs), must go through the Cricket Hall of Fame T20 World Cup Legends Tournament Committee (working with the Host Committee).

The Cricket Hall of Fame T20 world Cup Legends Tournament Committee will determine the designated areas with restrictions and ask for adequate security to protect the Legends and Officials in Players & Match Officials Areas (PMOA) and any other designated area(s).

Competition Structure

Playing Conditions:

T20 playing condition as per ICC (International Cricket Council).

Duckworth Lewis will be used if required.

Teams:

4 teams.

Pool:

One (1) pool of 4 teams.

Competition Format:

Teams in the group will play Round Robin (3 matches).

Top 2 team qualify for the Final after the completion of the Round Robin Stage will play the Final.

Cricket Balls:

Two new cricket balls of identical brand, make and quality will be provided by CCUSA for each game. Including any replacement during games.

Umpires:

Cricket Hall Of Fame T20 World Cup Legends Tournament Committee will appoint umpires for each game.

Scorer:

CCUSA official online scoring app will be used and CCUSA will appoint the official scorers.

Ranking

As per ICC - Points and Net Run Rate (NRR) tiebreaker will be used.

WIN

2 Points

NO RESULT

1 Point to both teams

A minimum of 6 overs must be bowled to the team batting first.

LOSS / ABANDONED

0 Points (Abandoned game may be subject to reschedule if time permits)

TIE BREAKER

1. > Head to Head Result

2. > NRR

3. > Number of Wins in pool

Eligibility

Team Composition

- Each team shall be comprised of maximum of 13 players for each match.
- Each Team is allowed to have up to 2 players over 45 in the playing 13 nominated players for each match

Batting

Any 11 Players are permitted to bat (in this case 10 out will be 'All Out') out of 13 nominated.

Runners

Any one out of 13 nominated players

Bowling

Any 13 Players are permitted to bowl out of 13 nominated (substitute can bowl).

Team Squad ("Roster")

Each team must provide match referee list of 20 players.

Each team can have up to 6 over 45 International Players

The Team shall be submitted to the Cricket Hall Of Fame T20 World Cup Legends Tournament Committee in writing or via email by

Day_____ Month_____ 2021.

Once accepted and approved by the Tournament Committee, no additional players may participate in the Tournament after the Tournament start previously agreed by Cricket Hall Of Fame T20 World Cup Legends Tournament Committee in good faith owing to accident, injury or some other unpredictable circumstances that the Cricket Hall Of Fame T20 World Cup Legends Tournament Committee deem as sufficient reason for the change.

Final Game Eligibility Criteria

Each player taking the field in the final must be a member of the "Approved Team Squad & must have played at least one round robin game". There will be NO Exceptions regarding player participation as a "declared player" in the Final (unless previously agreed to by Cricket Hall Of Fame T20 World Cup Legends Tournament Committee).

Ready to Play

Ready to play means a minimum of 9 players in the official, present at the ground and in clear visible view of the umpires.

Registration Fee: \$5,000

Registration fee is non-refundable. If the team is registered and failed to show or cancelled their registration, the registration fee will not be refunded.

It is the responsibility of the participating team management and its representative, such as coach/manager and/or any appointed official, to complete the visa application process for each International player and the team.

Participation of the team will be confirmed when the registration fee is paid in full and accepted by the CHoF T20 WCLTC.

Deadline for Registration:

Tournament Schedule

The tournament will start on September 27, and the finals will be played on September 30, 2021.

- All teams are requested to arrive on September 26th before 4 PM
- All teams must attend the Opening and Closing ceremonies.
- Toss will be done 45 minutes before the match start time.
- Before the toss the captains will submit the list of players nominated for the match to the umpire coordinating the toss.
- All teams must play their scheduled match on the exact scheduled date & time, no request will be accepted for amendment to the date and/or time.

NO Late arrival request will be accepted.

If the team arrives late for the match, overs will be reduced for the that specific team only.

Delayed Start due to late Arrival of the team.

Whether batting first or second, team is not entitled to the number of overs that are lost during the delay. This means the team that is not late will receive full 20 overs for bating (first or second) For example, If the delay is twenty (20) minutes in a regular match, then the maximum number of overs the defaulting team will face will be reduced to $(85 - 20)/4.2 = 16$ overs.

- The Power Play overs will be adjusted accordingly.

Rained out situation and unexpected delays.

- If tournament is affected by rain or unexpected delays following rules may be applied.
- In case of rain or unexpected delays affect the day, matches may be played with reduce overs.
- If full day is lost due to rain or unexpected delays, all remaining matches in the round robin stage may be played with reduce overs as determined by the tournament committee.
- If tournament is affected by the rain or unexpected delays for more than a day or two, the tournament committee will make the final decision on all situations and the committee decision will be final.
- The player/player support personnel who have been suspended/banned in accordance with the ICC Code of Conduct for Players and Player Support Personnel are not allowed to participate in the tournament in any capacity.

Insurance

To provide players medical insurance, every player is required to register with CCUSA (please visit CCUSA website or contact your team management).

Players will not be eligible for medical coverage under the CCUSA Medical Insurance Policy (MIP).

Waiver

Every player participating in the Cricket Hall of Fame T20 World Cup Legends Tournament 2021 , here in referred to as Legends World Cup, MUST sign the Tournament COVID 19 waiver form.

It is the team management's responsibility to ensure that all players meet this requirement.

T20 Playing conditions

The International Cricket Council Standard T20 International match playing conditions will be applied along with specific CHOF / CCUSA rules

SUPER OVER

One-over per side eliminator

Procedures for the "Super Over" per side eliminator

- Subject to weather conditions the one over per side eliminator will take place on the scheduled day of the match at a time to be determined by the Tournament Committee.
- In normal circumstances it shall commence five (5) minutes after the conclusion of the match.
- If the one over per side eliminator cannot start before the scheduled or rescheduled cut-off time for the completion of the match, it shall not be played. For the avoidance of doubt, the cut-off time for starting the eliminator will include any previously unused extra time remaining at the end of the match.
- The one per side eliminator will take place on the pitch allocated for the match (the designated pitch) unless otherwise determined by the umpires in consultation with ground authorities and the Tournament Officials.
- Prior to the commencement of the one over per side eliminator each team elects three (3) batsmen and one (1) Bowler.

SUPER OVER - Continued.

- The nominated players are given in writing to the umpires/Tournament Officials.
- Only players who played during the regular game can participate in the eliminator.
- Should any player be unable to continue to participate in the eliminator due to injury, illness or other wholly acceptable reasons, the relevant laws and playing conditions as they apply in the main match shall also apply in the eliminator?
- Any penance time being served in the main match shall be carried forward to the eliminator.
- The umpires shall stand at the same end as that in which they finished the match.
- The umpires shall choose which end to bowl and both teams will bowl from the same end.

- The team batting second in the match will bat first in the one over eliminator.
- The same ball at the end of the team's innings shall be used for the "extra" over but no new balls.
- Team fielding second may choose to use the same ball as chosen by the team bowling first.
- If the ball needs to be changed, then playing conditions as stated for the main match shall apply.
- The loss of two (2) wickets in the over ends the team's one (1) over innings.
- In the event of the teams having the same score after the one over eliminator has been completed, the team that hit the most number of boundary sixes combined from its two innings in the both the main match and the one (1) over per side eliminator shall be the winner.

SUPER OVER - Continued...

- If the number of boundary sixes hit by both teams is equal, the team whose batsmen score the most number of boundaries from its two innings in both the main match and the one over per side eliminator shall be the winner.
- If the number of boundaries from the two innings in both the main match and the one over per side eliminator are equal, the team which took the most number of wickets combined in the both the main match and the one over per side eliminator shall be the winner.
- If still equal, a count-back from the final ball of the one over eliminator shall be conducted. The team with the higher scoring delivery shall be the winner.
- If a team loses two wickets during its over, then any deliveries will be counted as dot balls.


Note that for this purpose, the runs scored from a delivery is defined as the total team runs scored since the completion of the previous legitimate ball, i.e., including any runs resulting from wide balls, no ball or penalty runs.

CHOF & CCUSA would like to promote a culture of inclusiveness, diversity, friendship, and family-oriented fun. It is not uncommon for friends, family, and kids to join in the proceedings as spectators during the matches.




Cricket Hall Of Fame T20 World Cup Legends Tournament Committee will strictly implement and observe this code of conduct should participants violate any of the below clauses or indulge in behavior.


CHOF & CCUSA would continue to take the necessary steps to maintain this decorum.
